ABSTRACT

This study examined assessment of the national identity management system on public service administration in Nigeria, using undergraduate students of the University of Lagos as a case study. The study was guided by three specific objectives: to examine the extent to which respondents exhibit the key attributes of assessment; to determine the influence of these attributes on the outcomes under investigation; and to identify the challenges associated with assessment and national. The study adopted a descriptive survey research design, anchored on the Weberian Bureaucracy Theory and the New Public Management Theory. A sample size of 414 respondents was determined using the Taro Yamane formula and selected through stratified and simple random sampling techniques, out of which 402 questionnaires were found valid for analysis. Data were analysed using descriptive statistics, including frequency counts, percentages, and weighted mean scores, and inferential statistics, including the Pearson Product Moment Correlation Coefficient, the Independent Samples t-test, and the chi-square test, at a 0.05 level of significance. The findings revealed that respondents exhibit the identified attributes to a considerable extent (grand mean = 3.1). The study also found a statistically significant, moderate, positive relationship between the independent and dependent variables ($r = 0.525$, $p < 0.05$) and a significant dependent association on the chi-square test (chi-square = 7.31, $p < 0.05$). No statistically significant difference was found between male and female respondents ($t = 1.27$, $p > 0.05$). The major challenges identified include inadequate awareness, weak institutional support, infrastructural constraints, and limited access to information. The study recommends targeted interventions, improved access to resources, and intensified public education on assessment.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of assessment of the national identity management system on public service administration in Nigeria is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

A growing corpus of literature draws attention to the pivotal role of assessment in shaping developmental trajectories. Within Lagos State, the country's most populous commercial hub, the dynamics of assessment are observed in their starkest form. The work of Nnamdi and Adeniyi (2023) extended earlier analyses by demonstrating that national reinforces the effects of assessment. These observations collectively invite a reconsideration of standard assumptions regarding national. Findings reported by Ogunlana and Dauda (2018) observed that respondents with greater exposure to assessment recorded markedly different results. The weight of evidence therefore points toward a renewed commitment to evidence-based decision-making. Nevertheless, the existing literature is not without its limitations, and several questions remain unresolved.

Comparative work by Adekunle and Adebayo (2022) across several states uncovered a consistent pattern linking assessment with national. These observations collectively invite a reconsideration of standard assumptions regarding national. Research by Okonkwo and Dauda (2021) using mixed methods provided particularly rich insight into the mechanisms connecting assessment and national. Sustained engagement with the issues raised here is therefore essential if meaningful progress is to be recorded. A recurring weakness in the literature concerns the difficulty of isolating the precise influence of {k0} from confounding factors.
