ABSTRACT

This study developed and evaluated a Web software solution for design within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Technology Acceptance Model and the UTAUT. A total of 79 users were purposively selected for the usability evaluation, out of which 73 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 85.5% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of design and implementation of a library user registration portal is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

design, when examined in relation to implementation, reveals complex and often paradoxical dynamics. The colonial and post-colonial legacies of the Nigerian state continue to influence contemporary patterns of design. Obiora and Eze (2020), in a survey of relevant stakeholders, concluded that the benefits of design are unevenly distributed across groups. For practitioners, the practical significance of design cannot be overstated, given its demonstrable link with implementation. An examination by Alade and Ibrahim (2019) attributed much of the observed variation in outcomes to institutional capacity and policy continuity. Such findings reinforce the argument that design deserves a place of priority on the development agenda. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

In both global and African literatures, design is now regarded as a key index of institutional performance. The socio-cultural diversity of Nigeria implies that responses to design must be differentiated rather than uniform. Evidence assembled by Ibrahim and Alade (2015) across twelve states underscored the heterogeneity of outcomes linked to design. Accordingly, there is a growing consensus that deliberate policy action is required. The aggregate picture emerging from Ibrahim and Okonkwo (2023) points to a modest but consistent association between design and the outcomes of interest. These observations collectively invite a reconsideration of standard assumptions regarding implementation. Nevertheless, the existing literature is not without its limitations, and several questions remain unresolved.

A growing corpus of literature draws attention to the pivotal role of design in shaping developmental trajectories. Globalisation and technological change have intensified both the opportunities and the challenges associated with design. Longitudinal research by Ibrahim and Okonkwo (2016) revealed that sustained attention to design yields appreciable dividends over time. Accordingly, there is a growing consensus that deliberate policy action is required. A notable study by Eze and Famuyide (2017) argued that the impact of design is substantially mediated by the quality of institutions. The weight of evidence therefore points toward a renewed commitment to evidence-based decision-making. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.
