ABSTRACT

This study developed and evaluated a Web software solution for development within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Structural Load Theory and the Soil Mechanics Theory. A total of 76 users were purposively selected for the usability evaluation, out of which 72 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 89.8% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of development of a contractor bidding and tender management portal is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

Over the past two decades, development has become increasingly significant within the Nigerian landscape and beyond. Rapid urbanisation and demographic expansion across Nigerian cities have heightened the salience of development in everyday life. Research by Umeh and Ibrahim (2021) using mixed methods provided particularly rich insight into the mechanisms connecting development and contractor. The weight of evidence therefore points toward a renewed commitment to evidence-based decision-making. Nwosu and Kalu (2020), in a survey of relevant stakeholders, concluded that the benefits of development are unevenly distributed across groups. These developments carry important implications for policy and practice in civil engineering. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

Scholars have long recognised development as a critical determinant of outcomes in civil engineering. The colonial and post-colonial legacies of the Nigerian state continue to influence contemporary patterns of development. Field evidence gathered by Bakare and Eze (2016) suggested that stakeholder engagement materially improves the results achieved in matters of development. For practitioners, the practical significance of development cannot be overstated, given its demonstrable link with contractor. The work of Olawale and Adekunle (2023) extended earlier analyses by demonstrating that contractor reinforces the effects of development. Sustained engagement with the issues raised here is therefore essential if meaningful progress is to be recorded. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

Over the past two decades, development has become increasingly significant within the Nigerian landscape and beyond. The Nigerian context presents peculiar challenges, ranging from infrastructural deficits to institutional weaknesses, which shape the manner in which development unfolds. A notable study by Olawale and Adekunle (2017) argued that the impact of development is substantially mediated by the quality of institutions. For practitioners, the practical significance of development cannot be overstated, given its demonstrable link with contractor. An examination by Dauda and Nwosu (2019) attributed much of the observed variation in outcomes to institutional capacity and policy continuity. The practical import of these findings extends well beyond the academic sphere into everyday institutional practice. Nevertheless, the existing literature is not without its limitations, and several questions remain unresolved.
