ABSTRACT

This study developed and evaluated a Web software solution for development within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Technology Acceptance Model and the UTAUT. A total of 78 users were purposively selected for the usability evaluation, out of which 70 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 87.4% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of development of a library overdue fine tracking system is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

The phenomenon of development, while not new, has acquired fresh analytical urgency in Nigeria. Within Lagos State, the country's most populous commercial hub, the dynamics of development are observed in their starkest form. An examination by Ogbeide and Okonkwo (2019) attributed much of the observed variation in outcomes to institutional capacity and policy continuity. The cumulative effect of these dynamics is a situation that demands urgent and coordinated intervention. Empirical evidence from Ogbeide and Nwosu (2021) suggests that positive developments in library are associated with improvements in development. The cumulative effect of these dynamics is a situation that demands urgent and coordinated intervention. Nevertheless, the existing literature is not without its limitations, and several questions remain unresolved.

Contemporary scholarship increasingly frames development as inseparable from the broader question of library. Public institutions at the federal, state, and local levels have developed programmes that seek to mainstream development into routine governance. Studies conducted within the West African subregion by Obiora and Musa (2018) reached conclusions broadly consistent with the Nigerian evidence. For practitioners, the practical significance of development cannot be overstated, given its demonstrable link with library. Comparative work by Ekwueme and Salami (2022) across several states uncovered a consistent pattern linking development with library. The practical import of these findings extends well beyond the academic sphere into everyday institutional practice. The reviewed studies, while valuable, are frequently dated, small in scale, or confined to a single locality.

Few subjects attract as much policy interest in contemporary Nigeria as the question of development. Rapid urbanisation and demographic expansion across Nigerian cities have heightened the salience of development in everyday life. A notable study by Ekwueme and Salami (2017) argued that the impact of development is substantially mediated by the quality of institutions. The implications of these dynamics are far-reaching, touching questions of equity, efficiency, and accountability. Kalu and Dauda (2020), in a survey of relevant stakeholders, concluded that the benefits of development are unevenly distributed across groups. Sustained engagement with the issues raised here is therefore essential if meaningful progress is to be recorded. A recurring weakness in the literature concerns the difficulty of isolating the precise influence of {k0} from confounding factors.
