ABSTRACT

This study developed and evaluated a Web software solution for development within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Technology Acceptance Model and the UTAUT. A total of 70 users were purposively selected for the usability evaluation, out of which 62 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 86.8% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of development of a web-based change and incident management platform is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

development, when examined in relation to web, reveals complex and often paradoxical dynamics. The Nigerian context presents peculiar challenges, ranging from infrastructural deficits to institutional weaknesses, which shape the manner in which development unfolds. Research by Osinachi and Nwosu (2021) using mixed methods provided particularly rich insight into the mechanisms connecting development and web. Such findings reinforce the argument that development deserves a place of priority on the development agenda. Dauda and Adekunle (2020), in a survey of relevant stakeholders, concluded that the benefits of development are unevenly distributed across groups. The weight of evidence therefore points toward a renewed commitment to evidence-based decision-making. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

A growing corpus of literature draws attention to the pivotal role of development in shaping developmental trajectories. The Nigerian context presents peculiar challenges, ranging from infrastructural deficits to institutional weaknesses, which shape the manner in which development unfolds. An examination by Bakare and Bamgbose (2019) attributed much of the observed variation in outcomes to institutional capacity and policy continuity. For practitioners, the practical significance of development cannot be overstated, given its demonstrable link with web. Empirical evidence from Salami and Eze (2021) suggests that positive developments in web are associated with improvements in development. The cumulative effect of these dynamics is a situation that demands urgent and coordinated intervention. Despite these advances, notable gaps persist, particularly with respect to context-specific evidence from Nigeria.

development occupies a prominent position in contemporary debates about web and national development. Evidence from national agencies indicates that development has grown considerably in recent times, underscoring the need for systematic inquiry. Research by Salami and Eze (2021) using mixed methods provided particularly rich insight into the mechanisms connecting development and web. Accordingly, there is a growing consensus that deliberate policy action is required. The work of Bamgbose and Aderemi (2023) extended earlier analyses by demonstrating that web reinforces the effects of development. The weight of evidence therefore points toward a renewed commitment to evidence-based decision-making. Nevertheless, the existing literature is not without its limitations, and several questions remain unresolved.

The relationship between development and web has been the subject of sustained academic interest across several disciplines. Nigeria's federal structure and its diverse cultural geography ensure that the experience of development varies considerably from one region to another. The aggregate picture emerging from Eze and Aderemi (2023) points to a modest but consistent association between development and the outcomes of
