ABSTRACT

This study developed and evaluated a Web software solution for development within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Technology Acceptance Model and the UTAUT. A total of 73 users were purposively selected for the usability evaluation, out of which 63 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 85.2% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of development of a web-based cloud compliance and security posture dashboard is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

A growing corpus of literature draws attention to the pivotal role of development in shaping developmental trajectories. Nigeria's federal structure and its diverse cultural geography ensure that the experience of development varies considerably from one region to another. Comparative work by Ogunlana and Alade (2022) across several states uncovered a consistent pattern linking development with web. Such findings reinforce the argument that development deserves a place of priority on the development agenda. Field evidence gathered by Okonkwo and Alade (2016) suggested that stakeholder engagement materially improves the results achieved in matters of development. Sustained engagement with the issues raised here is therefore essential if meaningful progress is to be recorded. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

The salience of development in national discourse has grown steadily, driven by changing social conditions and technological penetration. Within Lagos State, the country's most populous commercial hub, the dynamics of development are observed in their starkest form. Findings reported by Salami and Adebayo (2018) observed that respondents with greater exposure to development recorded markedly different results. Left unaddressed, the identified patterns are likely to intensify, with adverse consequences for all stakeholders. The aggregate picture emerging from Okonkwo and Ekwueme (2023) points to a modest but consistent association between development and the outcomes of interest. The practical import of these findings extends well beyond the academic sphere into everyday institutional practice. It is therefore imperative that further empirical work be undertaken to clarify the causal relationships at stake.

In both global and African literatures, development is now regarded as a key index of institutional performance. Nigeria's federal structure and its diverse cultural geography ensure that the experience of development varies considerably from one region to another. Evidence assembled by Okonkwo and Ekwueme (2015) across twelve states underscored the heterogeneity of outcomes linked to development. The implications of these dynamics are far-reaching, touching questions of equity, efficiency, and accountability. Longitudinal research by Umeh and Adebayo (2016) revealed that sustained attention to development yields appreciable dividends over time. These observations collectively invite a reconsideration of standard assumptions regarding web. Despite these advances, notable gaps persist, particularly with respect to context-specific evidence from Nigeria.

Debates on national transformation repeatedly return to the role of development and its attendant dynamics. Rapid urbanisation and demographic expansion across Nigerian cities have heightened the salience of development in everyday life. The work of Okonkwo and Obiora (2023) extended earlier analyses by
