ABSTRACT

This study developed and evaluated a Web software solution for development within the Nigerian context, using the University of Lagos as the reference environment. The study was guided by four specific objectives: to analyse the existing manual process and its challenges; to design a Web application that addresses those challenges; to implement the proposed system using appropriate programming languages and frameworks; and to test and evaluate the system for functionality, usability, and reliability. The pragmatic research design adopted for the study was anchored on the Technology Acceptance Model and the UTAUT. A total of 70 users were purposively selected for the usability evaluation, out of which 61 responses were found valid for analysis. Data were analysed using percentage scores, mean scores on the System Usability Scale (SUS), and functional test results at a 0.05 level of significance. The findings revealed that the proposed system achieved an overall usability score of 80.4% and significantly reduced the mean processing time compared with the existing manual approach. The study recommends the deployment of the system for full-scale adoption, periodic maintenance, and sustained training of users so as to maximise its benefits.

CHAPTER ONE: INTRODUCTION

1.1 Background to the Study

The study of development of a web-based distributed backup and file synchronisation system is situated within a body of scholarship that has grown rapidly in the past two decades. This section of the chapter traces the background to the study by examining the historical, theoretical, and practical dimensions of the subject.

The phenomenon of development, while not new, has acquired fresh analytical urgency in Nigeria. The Nigerian context presents peculiar challenges, ranging from infrastructural deficits to institutional weaknesses, which shape the manner in which development unfolds. Adeniyi and Adigun (2020), in a survey of relevant stakeholders, concluded that the benefits of development are unevenly distributed across groups. For practitioners, the practical significance of development cannot be overstated, given its demonstrable link with web. The aggregate picture emerging from Adekunle and Salami (2023) points to a modest but consistent association between development and the outcomes of interest. Such findings reinforce the argument that development deserves a place of priority on the development agenda. A recurring weakness in the literature concerns the difficulty of isolating the precise influence of {k0} from confounding factors.

Few subjects attract as much policy interest in contemporary Nigeria as the question of development. Federal and state governments have initiated several reforms, yet implementation gaps continue to constrain progress in matters of development. Longitudinal research by Adekunle and Salami (2016) revealed that sustained attention to development yields appreciable dividends over time. Research by Olawale and Bamgbose (2021) using mixed methods provided particularly rich insight into the mechanisms connecting development and web.
